**Certain Zinc Coated (Galvanised) Steel exported from the People’s Republic of China, Taiwan and the Republic of Korea and Certain Aluminium Zinc Coated Steel exported from the People’s Republic of China and the Republic of Korea**

The Anti-Dumping Review Panel (“ADRP”) received an application from BlueScope Steel Limited for a review of the decisions of the Parliamentary Secretary to the Minister for Industry, Innovation and Science, made on 19 July 2017, to publish notices under subsection 269ZDB(1)(a) of the *Customs Act 1901* (“the Act”) following a review of anti-dumping measures in respect of Certain Zinc Coated (Galvanised) Steel and Certain Aluminium Zinc Coated Steel Exported from the Republic of Korea by Donbgu Steel Co Ltd (“the Reviewable Decisions”).

The Parliamentary Secretary’s decisions were published on the Anti-Dumping Commission (“ADC”) website on 20 July 2017 ([ADN 2017/86](#) and [ADN 2017/87](#)).

The ADRP is satisfied that the following grounds are reasonable grounds for the reviewable decisions not being the correct or preferable decision:

- (a) in establishing revised variable factors for the nominated exporters, the Assistant Minister failed to consider the significant increases in raw material prices in the period subsequent to the review period (and up to the date of the decision); and
- (b) the Assistant Minister should not have accepted the Commissioner’s recommendation to set an exporter’s export price equal to its normal value in the absence of any exports by that exporter during the review period.

The goods to which this application relates are:

Certain Zinc Coated (Galvanised) Steel exported to Australia from the Republic of Korea (“Korea”) by Donbgu Steel Co. Ltd:

*“flat rolled products of iron and non-alloy steel, of a width less than 600 mm and, equal to or greater than 600 mm, plated or coated with zinc”*

Certain Aluminium Zinc Coated Steel exported to Australia from the Republic of Korea by Donbgu Steel Co. Ltd:

*“flat rolled products of iron and non-alloy steel of a width equal to or greater than 600 mm, plated or coated with aluminium-zinc alloys, not painted, whether or not including resin coating”.*

Additional information about the goods is described in the Anti-Dumping Commission Report 385 and 386.

The ADRP proposes to conduct a review of the decision.
