**Steel Rod in Coils exported from the Republic of Indonesia, the Republic of Korea and the Socialist Republic of Vietnam**  
**Application by: OneSteel Manufacturing Pty Ltd**

Please be advised that the Anti-Dumping Review Panel (ADRP) Review No. 82: Steel Rod in Coils exported from the Republic of Indonesia, the Republic of Korea and the Socialist Republic of Vietnam was initiated on 15 May 2018.

The applicant seeking review of the Commissioner's decision to terminate Investigation 416 is OneSteel Manufacturing Pty Ltd.

  - (2) confidential correspondence and other confidential documents not on the EPR.
5. Any other confidential records/documents that contain information about the grounds raised by OneSteel.
