**ADRP Review No. 93: Certain Hollow Structural Sections exported from the Kingdom of Thailand**  
**Application by: Austube Mills Pty Ltd**

Please be advised that the Anti-Dumping Review Panel (ADRP) Review No. 93 of Certain Hollow Structural Sections exported from the Kingdom of Thailand was initiated on 13 August 2018.

For the purpose of obtaining further information in relation to the review, the ADRP Member requests the Anti-Dumping Commission (ADC) provide the following documents:

- If the ground relates to normal value, please provide the export visit report, plus any confidential information/spreadsheets sent to the exporter regarding the calculation of the normal value, export price and dumping margins.
5. Any other records/documents that contain information about the verification report/s or relating to the specific ground of the review application.
