Notice under section 269ZZI

A4 Copy Paper exported from Austria, Finland, the Republic of Korea, the Russian Federation and the Slovak Republic

The Anti-Dumping Review Panel (ADRP) has received applications for review of the decision by the Minister for Industry, Science and Technology to publish a dumping duty notice under subsections 269TG(1) and (2) of the *Customs Act 1901* in respect of A4 Copy Paper exported from Austria, Finland, the Republic of Korea, the Russian Federation and the Slovak Republic (the Reviewable Decision). The applications were made by Hankuk Paper Mfg Co., Ltd (Hankuk) and Mondi SCP a.s (Mondi).

The Minister's decision was published on the Anti-Dumping Commission's (ADC) website on 10 April 2019 (ADN 2019/37).

The ADRP is satisfied that the following grounds are reasonable grounds for the reviewable decision not being the correct or preferable decision:

(a) **Mondi;**

Ground 1: There is nothing in the ADC's analysis contained within Report 463 which substantiates the Minister's opinion that Mondi may engage in dumping as required by the stipulation in section 269TG(2)(a) that "*the amount of the export price of like a good that may be exported to Australia in the future may be less than the normal value of the goods of [that] exporter*"; and

Ground 2: The Minister's finding that although dumping found to have occurred in 2017 did not cause material injury to the Australian industry in 2017, nevertheless it did cause material injury to the Australian industry in 2018 is not supported by the ADC's analysis contained within Report 463.

(b) **Hankuk;**

Ground 1: The injury to the Australian Industry referenced in Report 463 has not been caused because of Hankuk's exports;

Ground 2: The evidence referenced in Report 463 does not support the causation finding; and

Ground 3: There is insufficient evidence contained within Report 463 to support the finding that the Australian industry sustained material injury.

The ADRP proposes to conduct a review of the Reviewable Decision in relation to the above grounds.

The goods to which these applications relate are:

uncoated white paper of a type used for writing, printing or other graphic purposes, in the nominal basis weight range of 70 to 100 gsm and cut to sheets of metric size A4 (210 mm x 297 mm) (also commonly referred to as cut sheet paper, copy paper, office paper or laser paper).

Further information on the goods:

The paper is not coated, watermarked or embossed and is subjectively white. It is made mainly from bleached chemical pulp and/or from pulp obtained by a mechanical or chemi-mechanical process and/or from recycled pulp.

Interested parties have **30 days** from the date this notice is published to provide the ADRP with a submission.

If your submission contains confidential information, you must provide a public version that can be published on the ADRP website. Failure to do so will result in your submission not being considered.
