Dear Anti-Dumping Review Panel Secretariat,

I write as an authorised representative for the PanAsia Group with respect to the Group's application to the Anti-Dumping Review Panel (ADRP) for review of the decision of the Minister to secure the continuation of measures applying to Aluminium Extrusions exported from the People's Republic of China ([ADN 2020/103](#) refers).

I note that paragraphs [26]-[36] of the Grounds of Application lodged by the PanAsia Group indicate that two applications for duty assessment, seeking a refund of interim dumping and countervailing duties paid on its imports of the Goods subject to the anti-dumping measures in the period 28 October 2018 to 27 April 2019 (**DA0174**) and 28 April 2019 to 27 October 2019 (**DA0186**) remained outstanding at the time of submission. At that time, we were instructed that the due date for both preliminary decisions had been extended to 14 December 2020.

On 15 December 2020, our client was informed that the Commissioner had granted further extensions of time for the final recommendation in relation to both DA0174 and DA0186. We are informed by the Commission (see **attached**) that:

Both duty assessments are now due 30 days after the Minister's decision is published in relation to ADRP Review No 2020/129 (which concerns the dumping margin calculation for PanAsia Aluminium (China) Ltd). Based on current timeframes, the Minister's decision is expected on 1 March 2021. Accordingly, the Commission expects the new due dates to fall on 31 March 2021 (subject to further updates from the ADRP).

To that end, I would be grateful if this information could please be provided to the Senior Member as appropriate.
