ADRP Review No. 2020/130 Steel Reinforcing Bar exported from the Republic of Korea, Singapore, Spain (except Nervacero S.A.) and Taiwan (except Power Steel Co. Ltd.) Continuation Inquiry 546

As you are aware, a report of the findings of the reinvestigation conducted in respect of Anti-Dumping Review Panel (ADRP) Review No. 2020/130 is due to you by Wednesday, 7 April 2021.

I request an extension of 90 days (to Tuesday, 6 July 2021), to provide my reinvestigation report to you. I request this extension on the grounds that:

- you have requested that the normal value determined for the Korean exporter Daehan Steel Co., Ltd (Daehan) in Continuation Inquiry 546 be reinvestigated. On 12 March 2021, the Commission received a submission from Daehan¹ in respect of the conduct of the reinvestigation as it concerned its normal value. Daehan submitted that the Commission now has before it, a verified source of information that is most relevant to its normal value for the purposes of the reinvestigation. This information has been provided in respect of Review of Measures 566 steel reinforcing bar exported from the Republic of Korea, Singapore, Spain (except Nervacero S.A.) and Taiwan (except Power Steel Co. Ltd.) (Review 566):
- the Commission is currently considering Daehan's submission and is in the process of verifying the data and information supplied by Daehan in Review of Measures 566, which merits additional time and activities;
- the Commission has received other submissions from interested parties in relation to the reinvestigation, which are also subject to consideration;² and
- I now propose to publish a preliminary reinvestigation report on the public record to address the matters raised in the submissions.³ I will then have regard to all
