**CERTAIN ALUMINIUM EXTRUSIONS EXPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA**

The Anti-Dumping Review Panel (ADRP) has received applications from Tai Shan City Kam Kiu Aluminium Extrusion Co Ltd, and its related bodies corporate, Kam Kiu (Australia) Pty Ltd and Kam Kiu Aluminium Products SDN BDH (jointly, "Kam Kiu") and PanAsia Aluminium (China) Limited and Opal (Macao Commercial Offshore) Limited OPAL (jointly, "PanAsia") seeking review of a decision by the Parliamentary Secretary to the former Minister for Industry and Science to publish findings in relation to a review of anti-dumping measures in respect of certain aluminium extrusions exported from the People's Republic of China ('the Reviewable Decision'). The Reviewable Decision was published on 19 August 2015. Please find an electronic copy of the applications **attached**.

The ADRP invites the Anti-Dumping Commission (the Commission) to comment on the applications. These comments will assist the ADRP's consideration of the claims made in the applications. It would be of assistance to the ADRP's initial consideration of the applications if the comments would please address the following matters, as relevant:

1. Identify any information provided with, or referred to in the application that, in the view of the Commission, is *not relevant information* as defined in s.269ZZK(6) of the *Customs Act 1901*.
2. Identify any factual claims in the application that the Commission disputes, and refer to *relevant information* in that regard.
3. Provide some commentary on the grounds of the application, referring to *relevant information*.
4. If it seems appropriate, provide any additional background information in relation the matter, including referring to any relevant policy position or guidelines which had an impact on the decision under review.

The Commission is asked to supply a confidential and a non-confidential copy of the comments. Please provide any comments by 11 November 2015 (21 days) to [\*\*adrp@industry.gov.au\*\*](mailto:adrp@industry.gov.au).
