**CLEAR FLOAT GLASS exported from the PEOPLE'S REPUBLIC OF CHINA,
REPUBLIC OF INDONESIA AND THE KINGDOM OF THAILAND**

The Anti-Dumping Review Panel (ADRP) received an application from Guardian Industries Corp Ltd for a review of a decision by the Parliamentary Secretary to secure the continuation of the anti-dumping measures currently applying to exports of Clear Float Glass (CFG) from the People's Republic of China, Republic of Indonesia and The Kingdom of Thailand (the Reviewable Decision).

The Reviewable Decision was published on the Anti-Dumping Commission (ADC) website on 8 September 2016.

The ADRP is satisfied that the following grounds are reasonable grounds for the reviewable decision not being the correct or preferable decision:

- (a) the ADC's finding that dumping by Thai exporters is likely to continue or recur was not the correct or preferable finding;
- (b) the ADC's finding that CSR Viridian Ltd is threatened with material injury should measures be allowed to expire was not the correct or preferable finding;
- (c) the ADC's finding that future injury to CSR Viridian Ltd could be attributed to Thai dumping was not the correct or preferable finding;
- (d) the ADC's finding that the CSR Viridian Ltd does not directly or indirectly import large quantities of low-cost CFG from Xinyi or some other Asian exporter was not the correct or preferable finding;
- (e) the ADC misapplied s 269ZHF(2) of the *Customs Act 1901*; and
- (f) the ADC failed to properly calculate a non-injurious price.

The goods to which this application relates to are:

CFG in nominal thickness of 3 to 12 millimetres (mm).

The goods have the following characteristics:

- transparent;
- flat and
- rectangle or square in shape.

The ADRP proposes to conduct a review of the decision. Interested parties may make submissions to the Panel within **30 days** after the date of publication of this notice.
