Notice under section 269ZZM (4)

HOT ROLLED STRUCTURAL STEEL SECTIONS
Exported from JAPAN, THE REPUBLIC OF KOREA, TAIWAN AND THE KINGDOM
OF THAILAND

The Anti-Dumping Review Panel (ADRP) has completed a review of a decision of the former Parliamentary Secretary to the Minister for Industry and Science (the former Parliamentary Secretary) to impose dumping duties with respect to HOT ROLLED STRUCTURAL STEEL SECTIONS exported from JAPAN, THE REPUBLIC OF KOREA, TAIWAN AND THE KINGDOM OF THAILAND. The former Parliamentary Secretary's decision was published in the Australian on 20 November, 2014 (the Dumping Duty Notice).

Applications for review were made by SIAM YAMATO STEEL CO. LTD, NIPPON STEEL AND SUMITOMO METAL CORPORATION AND ONESTEEL MANUFACTURING PTY LTD. A copy of the applications and the ADRP's report to me is available on the ADRP website www.adreviewpanel.gov.au.

The ADRP has recommended that I revoke the former Parliamentary Secretary's decision made pursuant to section 269TG(1) and section 269TG(2) to the extent that it relates to the dumping margin for SIAM YAMATO STEEL CO. LTD and substitute a new decision varying the dumping margin for SIAM YAMATO STEEL CO. LTD to 18.00%.

I, KAREN ANDREWS, Parliamentary Secretary to the Minister for Industry and Science, have considered and accepted the recommendations and reasons for the recommendations made by the member of the ADRP, including all material findings of fact or law as set out in the ADRP report.

Therefore, in accordance with section 269ZZM(1) of the *Customs Act 1901* I determined, on 15 June 2015, to vary the Dumping Duty Notice, with effect from 20 November 2014, so that the dumping margin for SIAM YAMATO STEEL CO. LTD is varied to 18.00%.

Interested parties may seek a review of this decision by lodging an application with the Federal Court of Australia, in accordance with the requirements in the *Administrative Decisions (Judicial Review) Act 1977*, within 28 days of the publication of this notice.

Customs Tariff (Anti-Dumping) Act 1975

Variation of notice under section 8(5)

Having decided to vary the dumping margin for the HOT ROLLED STRUCTURAL STEEL SECTIONS exported to Australia by SIAM YAMATO STEEL CO. LTD, I am consequently required to consider the appropriate method for working out the interim dumping duty in accordance with subsection 8(5) of the *Customs Tariff (Anti-Dumping) Act 1975* (the Dumping Duty Act).

I have DETERMINED, pursuant to subsection 8(5) of the Dumping Duty Act that the interim dumping duty for the HOT ROLLED STRUCTURAL STEEL SECTIONS exported to Australia by SIAM YAMATO STEEL CO. LTD is worked out in accordance with the ad valorem duty method and that therefore the Dumping Duty Notice is varied, with effect from 20 November 2014, so that the effective rate of duty for HOT ROLLED STRUCTURAL STEEL SECTIONS exported to Australia by SIAM YAMATO STEEL CO. LTD is 18.00%.

Interested parties may seek a review of this decision by lodging an application with the Federal Court of Australia, in accordance with the requirements in the *Administrative Decisions (Judicial Review) Act 1977*, within 28 days of the publication of this notice.
