A4 Copy Paper Exported from the Federative Republic of Brazil, the People's Republic of China, the Republic of Indonesia and the Kingdom of Thailand (Investigation 341)

- 1 As you may be aware from the Anti-Dumping Review Panel website:
 - (a) An application was made by Paper Australia Pty Ltd in respect of the decision made on 17 March 2017 to terminate part of Investigation 341;
 - (b) The decision is the subject of Anti-Dumping Notice 2017/34;
 - (c) the Panel in respect of the application for review is constituted by me; and
 - (d) I have accepted the application.
- 2 I propose to hold a conference with the Anti-Dumping Commission and Paper Australia Pty Ltd in respect of this review at 10.00am (WST)/12.00pm(EST) on 4 May 2017 pursuant to s 269ZZRA of the Act. You will be separately notified of the arrangements for the conference.
- 3 The information which I seek to obtain at the conference is details of that information which was before the Commission, and which is relevant to or bears upon the application for review. You will appreciate that the Investigation was an extensive one. EPR 341 identifies some 226 documents.
- 4 It would assist the conduct of the conference if, no later than 5.00pm WST on 3 May 2017 each of the Commission and the applicant provided, in respect of each of the grounds, a written list of information said to be relevant to that ground. If further time is required to compile this information, please let me know.

- 5 If the information is contained in a document forming part of EPR 341, the list should:
- (a) identify the number of the document in EPR 341;
 - (b) identify, as specifically as possible, the passages or passages of the document which is relevant to the ground; and
 - (c) identify any information which is alleged to be confidential.
- 6 If the information does not form part of the EPR, the list should:
- (a) identify, as specifically as possible, any document containing the information;
 - (b) identify, as specifically as possible, the passages or passages of the document which is relevant to the ground; and
 - (c) identify any information which is alleged to be confidential.
- 7 It is not necessary to repeat references to information which is specifically identified in the application. For example, the reference at page 7 of the application to section 4.6.3.6.2 of the Termination Report need not be duplicated.
