HOT ROLLED STRUCTURAL STEEL SECTIONS EXPORTED FROM JAPAN, THE REPUBLIC OF KOREA, TAIWAN AND THE KINGDOM OF THAILAND – INVITATION TO COMMENT

The Anti-Dumping Review Panel (ADRP) has received applications from the following:

- **Siam Yamato Steel Co. Ltd** on **15/12/2014** ;
- **Nippon Steel & Sumitomo Metal Corporation** on **19/12/2014**; and
- **OneSteel Manufacturing Pty Ltd** on **22/12/2014**.

All seeking review of a decision of the Parliamentary Secretary to the Minister for Industry to Publish a Dumping Duty Notice in relation to Hot Rolled Structural Steel Sections exported from Japan, the Republic of Korea, Taiwan and the Kingdom of Thailand (the Reviewable Decision).

The Reviewable Decision was published on **20 November 2014**

The ADC report relevant to the applications for review is **Final Report No. 223** (Dumping)

The ADRP invites the Anti-Dumping Commission (the Commission) to comment on the applications. These comments will assist the ADRP's consideration of the claims made in the applications. 2. Identify any factual claims in the application that the Commission disputes, and refer to *relevant information* in that regard;
3. Provide some commentary on the grounds of the application, referring to *relevant information*; and
4. If it seems appropriate, any additional background information in relation to the matter, including referring to any relevant policy position or guidelines which impacted on the decision under review.

Please note that the invitation and the response will be placed on the public file. To that end, the Commission is requested to supply a confidential and non-confidential copy of the comments.

As the time for submissions by interested parties expires on **23 February 2015**, the Commission is also requested to provide any comments by **16 February 2015 (25 Days)** to:
