Description: The project is located approx 15km south of Ravenshoe in northern Queensland. It is a wind power project consisting of up to 94 wind turbine generators and associated infrastructure (including access tracks, underground and overhead powerlines, electricity substation and operations and maintenance facilities). The project will connect to the existing 275kV powerlines that cross the site.
