Purpose: Establish new facility

Capital expenditure: \$500 million or more

Description: Project Ulysses will convert bioethanol from domestic agricultural by products into both Sustainable Aviation Fuel (SAF) and renewable diesel. The principal features and components at this point in time include 18 Air Coolers (1-20t), 1 Boiler (20MW), 12 Storage Tanks (6-8ML), 7 Columns (25-60t), 3 Gas Compressors (150-400kW), 14 Reactors (8-60t), 35 Shell and Tube Heat Exchangers (1-16t), 27 Vessels (1-21t) and a Flare. There will also be packages for Refrigeration, Plant and Instrument Air and Nitrogen, along with systems for Firefighting, Fire and Gas Detection and Water Treatment. The plant will also include facilities for Truck Loading, a Warehouse and Workshop, a Process Control Room and a number of other Prefabricated Buildings. Jet Zero appointed a FEED Contractor in April 2025 and is progressing FEED. Jet Zero's current procurement strategy is to have the FEED Contractor deliver the Engineering, Procurement, Fabrication, Construction and Commissioning of the plant. Jet Zero can confirm that any appointed procurement entities, including the EPC or Head Contractor, will be contractually bound to comply with and report against, the final approved AIP Plan. Current key milestones are: Q2 2026 - Preliminary market enquiries Q2 2026 - Target completion of FEED Q2 2026 - Target FID Q3 2026 - Target signing EPC Contract, subject to gaining FID Q3 2026 - Target EPC commencement of preliminary Subcontract awards Q3 2028 - Target construction completion
