Description: The 780 MW (8 Hour) BESS will provide an innovative solution for large power users, offering stable power supply and addressing critical grid stability challenges. This project will be the catalyst for the construction of the new Powerlink Calcium substation where it will be connected to the National Electricity Network (NEM). Construction is planned to commence in 2027 with early procurement in late 2026.
