Description: The project includes a 450-megawatt (MW) solar farm, a 450 MW direct current (DC)-coupled battery energy storage system (BESS) with storage capacity of up to 3,600 megawatt hours (MWh), a 275 kilovolt (kV) overhead transmission line (OHTL), switchyard, and associated ancillary infrastructure. Lead construction contractor procurement will commence in late 2026, with construction anticipated to commence in Q1 2028. Procurement of small works packages is anticipated to commence approximately 6-9 months prior to works commencement.
