Capital expenditure: \$1 billion - \$2 billion

Description: The Petrel Gas project is a gas field located offshore at around 100m water depth in the Bonaparte Gulf offshore northern Australia. The development concept includes: - an unmanned platform for wells control and chemical injection - 2 production wells - an 18-inch multi-phase export pipeline in carbon steel to connect to Eni existing processing facilities. Eni Energy Bonaparte plans to finalize studies on the development concept and close out the issue of tenders for the main work packages. There will be an Engineering, Procurement, Construction (EPC) contracts for the Platform; Pipeline Fabrication; Transportation & Installation of all Facilities; and Wells and Drilling & Completion Services, with Eni Energy Bonaparte Pty Ltd as the Procurement entity. The main contractors will develop their work packages to break down the scope of work, and they will be the Procurement entities for those specific packages. The Project will predominantly be developed to encompass Eni's associated Australian and international policies, plans and standards.
