Purpose: Establish new facility

Capital expenditure: \$500 million or more

Description: The Project is the development of a greenfield data centre, which will involve demolition and bulk excavation, construction, fit out and commissioning of the data centre. The centre comprises electrical systems capable of managing 80MVA of power, the construction of commercial premises to house and operate data servers, including ancillary office space, parking and landscaping. Final investment decision has been reached with construction expected to commence in June 2025. Phase 1 is expected to be complete, commissioned and operational by July 2027, with each of the subsequent phases 2 to 5 completed on a six monthly basis. All phases of the data centre are expected to be complete by July 2029, subject to customer commitment and fitout. Early contractor engagement has commenced with an EPC contractor and the procurement of long-lead items have started. In addition to the EPC contractor, the Project Proponent will be procuring certain key goods and services.
