Name: New Richmond bridge and Traffic improvements

Location: Hawksbury, NSW

Type: Land transport facility

Purpose: Upgrade existing facility

Capital expenditure: \$500 million - \$1 billion

Description: The New Richmond Bridge & traffic improvements will be delivered in two stages. Stage 1 - The Driftway, will be delivered first to deliver early safety benefits to the community. The Project involves upgrading The Driftway including pavement, drainage, and intersection improvements between Londonderry Road and Blacktown Road. The preliminary works such site compound and utilities investigations started in Oct. 2025. Main works construction and Procurement of main packages started in Nov. 2025. Stage 2 would involve upgrading Bells Line of Road through North Richmond, new bridge over the Hawkesbury River, a bypass of Richmond town centre and an active transport connection between Richmond and North Richmond. Aiming to award the main D&C contract in Q2 2026.
