Purpose: Upgrade existing facility

Capital expenditure: \$500 million or more

Description: The proposed project is part of BHP's Copper South Australia Growth Program for a staged expansion of the existing Copper Smelter at BHP's Olympic Dam Asset to process copper concentrate from the wider Copper SA portfolio. The scope will include copper concentrate import and blending facilities, additional smelting capacity, additional refining capacity, and additional Non-Process Infrastructure to support the expansion program.
