

# Australian Industry Participation (AIP) plan Summary – Project Phase

## 1. Project Details

**Designated project proponent:** Roads and Maritime Services

**Project name:** F6 Extension Stage 1

**Description of the project:** The F6 Extension Stage 1 includes: Twin 4km tunnels linking the New M5 motorway at Arncliffe to President Avenue at Kogarah; Ramps between the main motorway tunnel and the surface intersection at President Avenue; Tunnel stubs for a future connection south to extend the F6 Extension; A new intersection at President Avenue including the widening and raising of President Avenue at this location; Provision of new shared cycle and pedestrian pathways connecting Bestic Street, Brighton-Le-Sands; Motorway support infrastructure including tunnel ventilation systems and the motorway control centre; New service utilities including a permanent power supply line and Minor adjustments to local roads in the project area.

**Estimated project value:** \$2.5B

### **5. AIP activities to be undertaken by procurement entities**

Based on extensive experience procuring roads for NSW, all items are expected to be ordered and supplied by Australian entities except where, due to extremely high levels of infrastructure activity in NSW, some items may need to be supplied by non-Australian entities where local suppliers are unable to meet demand.

The procurement entities within RMS and the NSW Government Transport cluster manage panels of suppliers — these panels are updated every three years to encourage participation, and to understand industry capabilities.

RMS maintains a current understanding of the capability and capacity of Australian entities through recurring market sounding processes. RMS conducted a market sounding in July 2018, with a planned process in the lead up to procurement commencement.

Roads and Maritime requires procurement entities to consult with vendor identification agencies, such as the Industry Capability Network at

to gain a current understanding of Australian capability and to identify capable competitive Australian entities suitable to supply goods or services to the project.
