5. AIP activities to be undertaken by procurement entities

Australian entities will be provided the same opportunity as other potential suppliers to access all opportunities in the Project by way of:

- The Phase 1 notification period, as described above, will allow entities to schedule in resources appropriate to meet the demands of the Phase 2 RFQ programme. This ability to schedule resources can be cascaded down through the tiers of the supply chain accordingly;
- Through the Project's adhering to Australian building codes and standards all Australian entities will, by virtue, have equal relevant ability to bid for their package of interest as their competitors;
- Equitable Supplier Engagement Process All RFQ's will have standard, pre-prescribed, response duration and deadlines. Each shortlisted group of bidding entities will be pre-notified of relevant RFQ package issue dates (minimum 7 calendar days' notice) and subsequently then concurrently issued the Formal RFQ package to ensure that a full, fair and reasonable opportunity to bid has been provided;
- RFQ Response Templates The Contractor will reduce cost of responding to RFQ's by facilitating
 electronic tender submissions, in standardised formats via specific trade package pricing
 templates. This will also seek to achieve consistent market responses, contributing to a
 streamlined internal commercial review process. These may take the form of a BOQ section/s,
 pricing Schedule Summary or similar;
- All RFQ responses will be subjected to The Contractor's own standard internal commercial review process; and
- Bidding entities will be encouraged to implement the intent of this AIP Plan, via the cascading of its requirements through all tiers of their associated supply chains.

Through over 50 years of operation, a presence in 7 countries and 18 cities, and over 3,600 employees, Multiplex has developed a significant commercial footprint. On occasion, it may be deemed appropriate to leverage off this to the advantage of successful bidding and delivering entities through:
