Name: Western Ridge Crusher Project

Location: Newman, Western Australia

Type: Mine or quarry

Purpose: Upgrade existing facility

Capital expenditure: \$500 million or more

Description: The BHP Western Australian Iron Ore business comprises four iron ore mining hubs within the Pilbara region of Western Australia including the Newman Joint Venture Mining and Processing Hub. The Western Ridge Crusher Project is being developed to safely transition production from the depleting Orebody 24 with an expected progressive ramp up of production commencing FY 2026 to a target of 20Mtpa from the Western Ridge mining area. The Project will include the development of a new mining area of Western Ridge, including construction of Process and Non process infrastructure, electrical transmission and distribution infrastructure, technology as well as mining pre-development and potential supply of mobile fleet.
