## 1. Description of Pattern

An Itron model CENTRON C1B electronic single phase Class 1 direct connected static watt hour meter (Figure 1) used to measure electrical energy.

## 1.1 Field of Operation

#### 1.2 Features/Functions

- One (1) element.
- Liquid crystal digital indicator having five (5) digits.
- Active energy measurement (Class 1).
- Data communications using 433 MHz.
- Bottom connect rectangular base.

## 1.4 Sealing Provision

Provision is made for the calibration adjustments to be sealed by the application of one or more mechanical seals (Figure 2).
