It is the submittor's responsibility to ensure that all instruments marked with this approval number are constructed as described in the documentation lodged with the Commission and with the relevant Certificate of Approval and Technical Schedule. Failure to comply with this Condition may attract penalties under Section 19B of the National Measurement Act and may result in cancellation or withdrawal of the approval, in accordance with the Commission's Document 106.

Auxiliary devices used with this instrument shall comply with the requirements of General Supplementary Certificate No S1/0/A.

The values of the performance criteria (maximum number of scale intervals etc.) applicable to the instrument shall be within the limits specified herein and in any approval documentation for the components where they are approved separately.

#### DESCRIPTIVE ADVICE

#### Pattern: approved 28/3/92

A converted Toledo model 840 weighing instrument of 30 000 kg maximum capacity with a verification scale interval of 10 kg. The pattern has been converted to a lever/load cell weighing instrument and now uses a Toledo model 0725 load cell of 227 kg capacity (as described in the documentation of NSC approval No S172) and a Toledo model 8520 digital indicator (as described in the documentation of NSC approval No S266).

- $\pm 1.0e$  for loads over 500e up to 2000e; and
- ±1.5e for loads over 2000e.
