## GENERAL

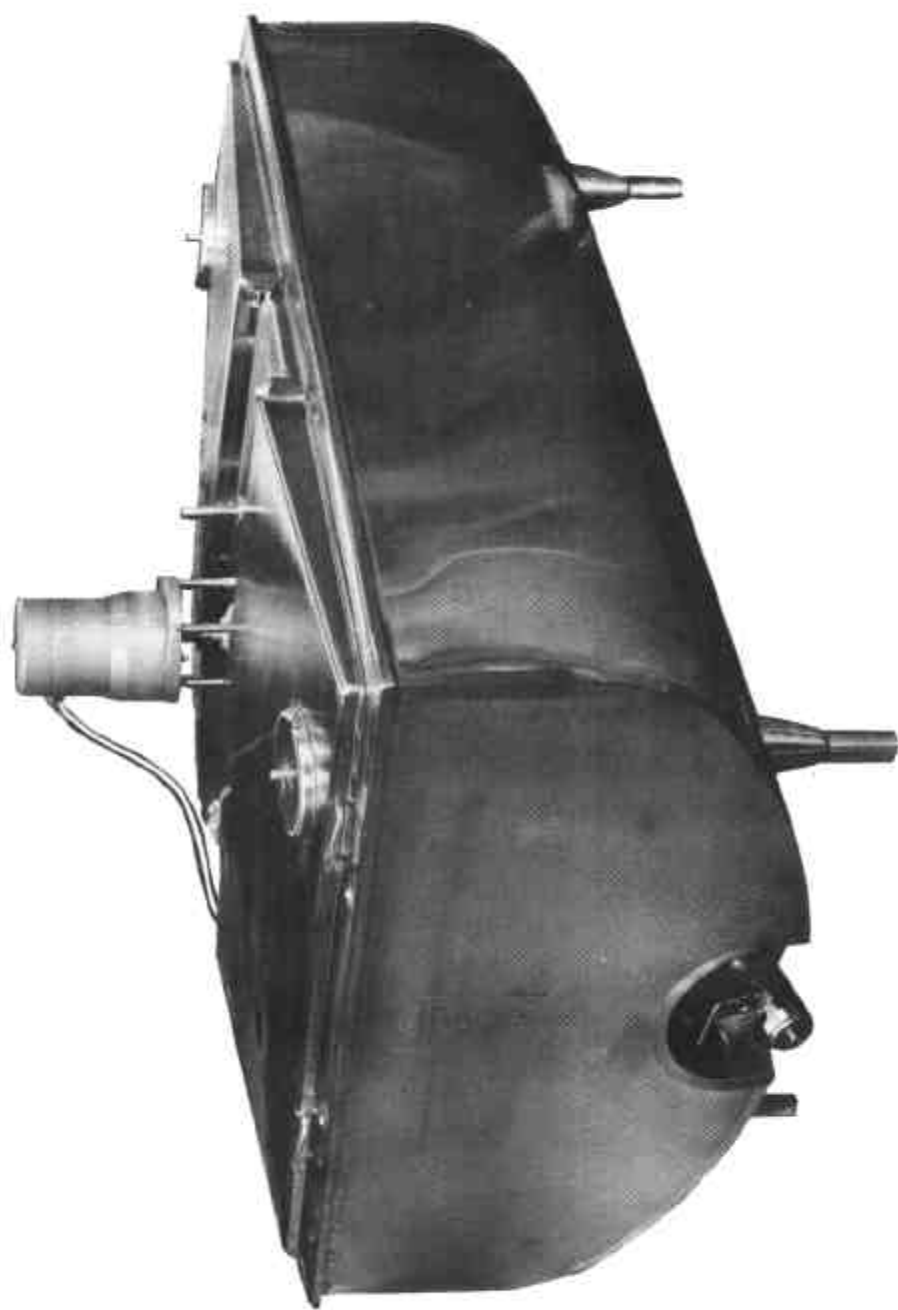


FIGURE 1 - The Pattern

The instrument described in this Certificate is a modification of the Sunset Model MC 300 Farm Milk Tank (see Figure 1). The modifications consist of changes in the dimensions of the tank.

## DESCRIPTION

The tank is rectangular in plan and 'U' shape in cross section. Two lids are hinged from the centrally positioned bridge which also supports the agitator and the dipstick.

The nominal overall dimensions of the pattern (see Figure 2) are 6 ft 7½ in long by 4 ft 6½ in wide.

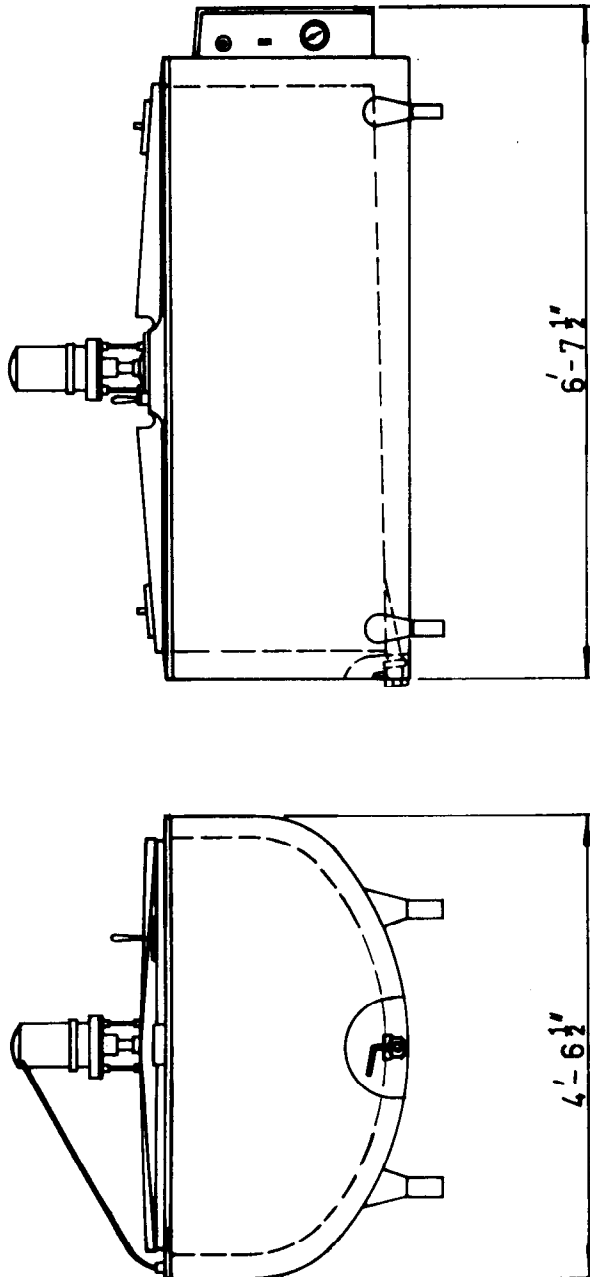


FIGURE - 2
